
THE FOLLOWING INSTRUCTIONS ARE FOR GUIDANCE ONLY AND SHOULD NOT BE SUBMITTED WITH THE APPLICATION

PREPARING YOUR PROPERTY FOR EVALUATION:

- A completed Site Plan (instructions to follow)
- FOR NEW SYSTEM EVALUATIONS:
 - Property must be cleared (mowed, bush-hogged, etc.) to permit easy access. This may require mowing tall weeds in a field or cutting bushes and limbing trees in a wooded area. If wooded lots are cleared, it is very important not to disturb existing soil or reshape lots in any way. Clearing with heavy equipment should only be done in dry conditions. Disturbance of soil may cause sites to be unsuitable for a septic system or may require a more expensive system. A permit that has been issued could be revoked due to site disturbance or construction in the area permitted for the septic system or repair area.
 - Property corners must be flagged. If owner/agent cannot find irons, then a licensed surveyor may be hired by the applicant to identify irons.
- FOR REPAIR EVALUATIONS:
 - Please indicate on the application what type of problem you are having (backing up in the house, in the yard, at the tank, etc.).

Make sure to indicate the following items on the site plan:

- Property Dimensions
- Proposed location of all structures on the property (garages, workshops, outbuildings, pools, water lines)
- The site you would prefer your septic permit to go
- The preferred location of the driveway
- The proposed well location
- A north arrow or other sufficient directional indicator
- The location of any existing septic tanks within 100 feet of your property line
- The location of any easements or rights of way on the property or any designated wetlands.
